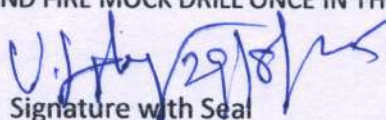

- (iv) AS PER NATIONAL BUILDING CODE 2016 ALL FIRE FIGHTING EQUIPMENTS SHOULD BE INSTALLED AND MAINTAIN PROPERLY. SHOULD BE DESIGNATE A PERSON RESPONSIBLE FOR FIRE AND LIFE SAFETY. SHOULD BE CONDUCT BASIC FIRE FIGHTING AND EVACUATION DRILL AND FIRE MOCK DRILL ONCE IN THREE MONTHS.
